EMERGENCY OVERVIEW

Incompatible Materials : Incompatible with strong oxidizers and with strong acids and bases

(decomposes to form formaldehyde). At melt temperatures, acetal resins are incompatible with halogenated polymers such as vinyl (PVC) and any elastomers containing any halogenated polymers. At processing conditions, these materials are mutually destructive and involve rapid degradation. Even small amounts of such contaminants can cause sudden and spontaneous formaldehyde gas formation. Workplace fume well above threshold levels are a likely result. Unsafe pressurization of equipment such as extruder or mold can also result.

Decomposition of this material depends on the lenght of time it is exposed to elevated temperatures. At the recommended processing temperature of 210°C-220°C (410°F-428°F), decomposition should not be significant until after 30 minutes. Decomposition may be accelerated by contaminants, pigments and/or other additives.
