#### Description of necessary first aid measures

**Eye contact**: Immediately flush eyes with plenty of water, occasionally lifting the

In order to avoid the generation of and exposure to 3,3'-dichlorobenzidine, do not use diarylide pigments in polymers when temperatures exceed 200°C (392°F). Handle with care. Organic dusts have the potential to be explosive with static spark or flame initiation.
