In order to avoid the generation of and exposure to $3,3'$ -dichlorobenzidine, do not use diarylide pigments in polymers when temperatures exceed $200 ^{\circ}C (392 ^{\circ}F)$ . Handle with care. Organic dusts have the potential to be explosive with static spark or flame initiation.
