Decabromodiphenyl oxide 1163-19-5 A halogenated aromatic with some potential for hazardous exposure via inhalation or ingestion. Acute toxicity is low - oral LD50 in rats >50 mg/L. Animal studies at high feeding levels indicate some potential for liver effects form chronic overexposure.
